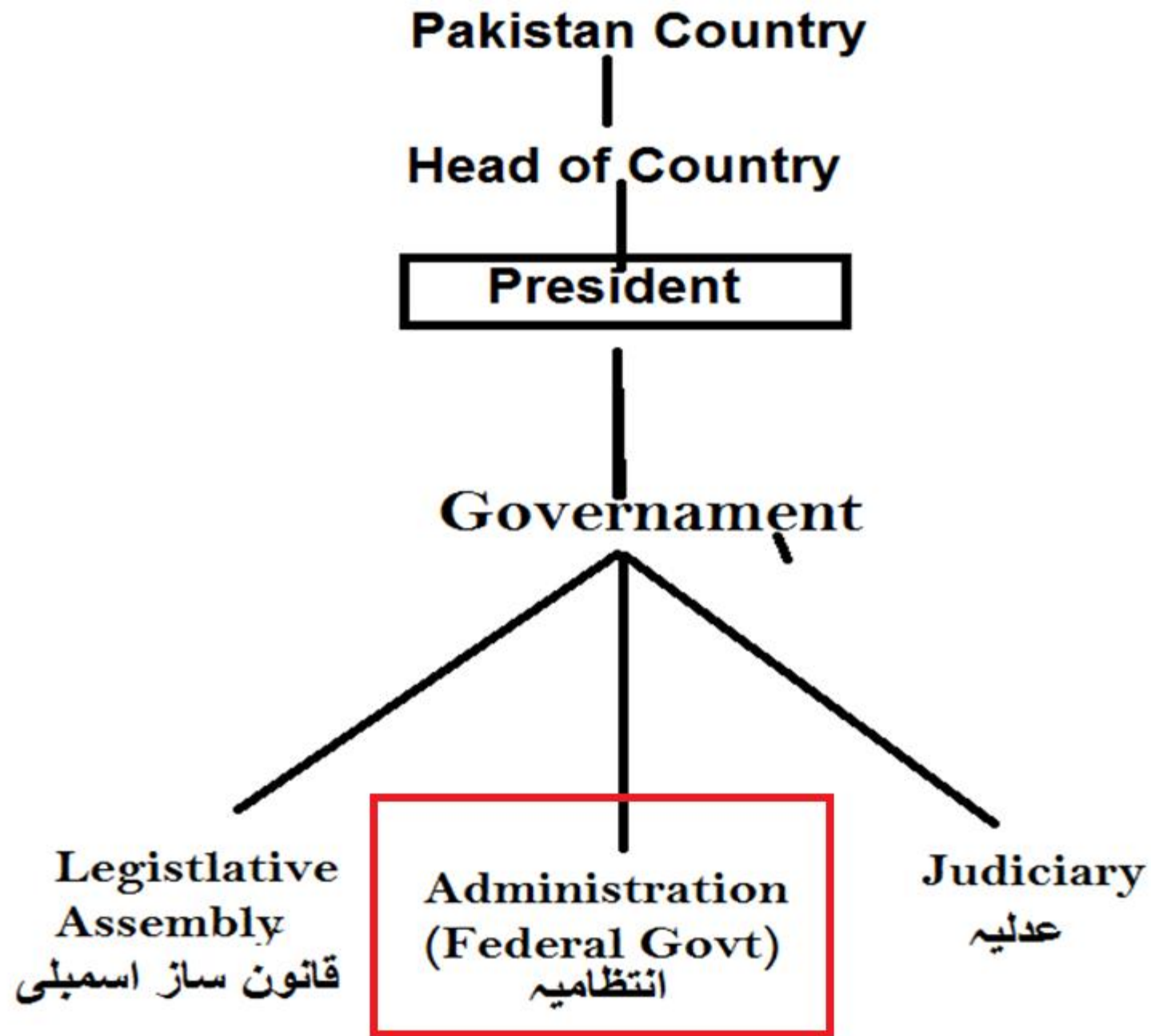

What is State



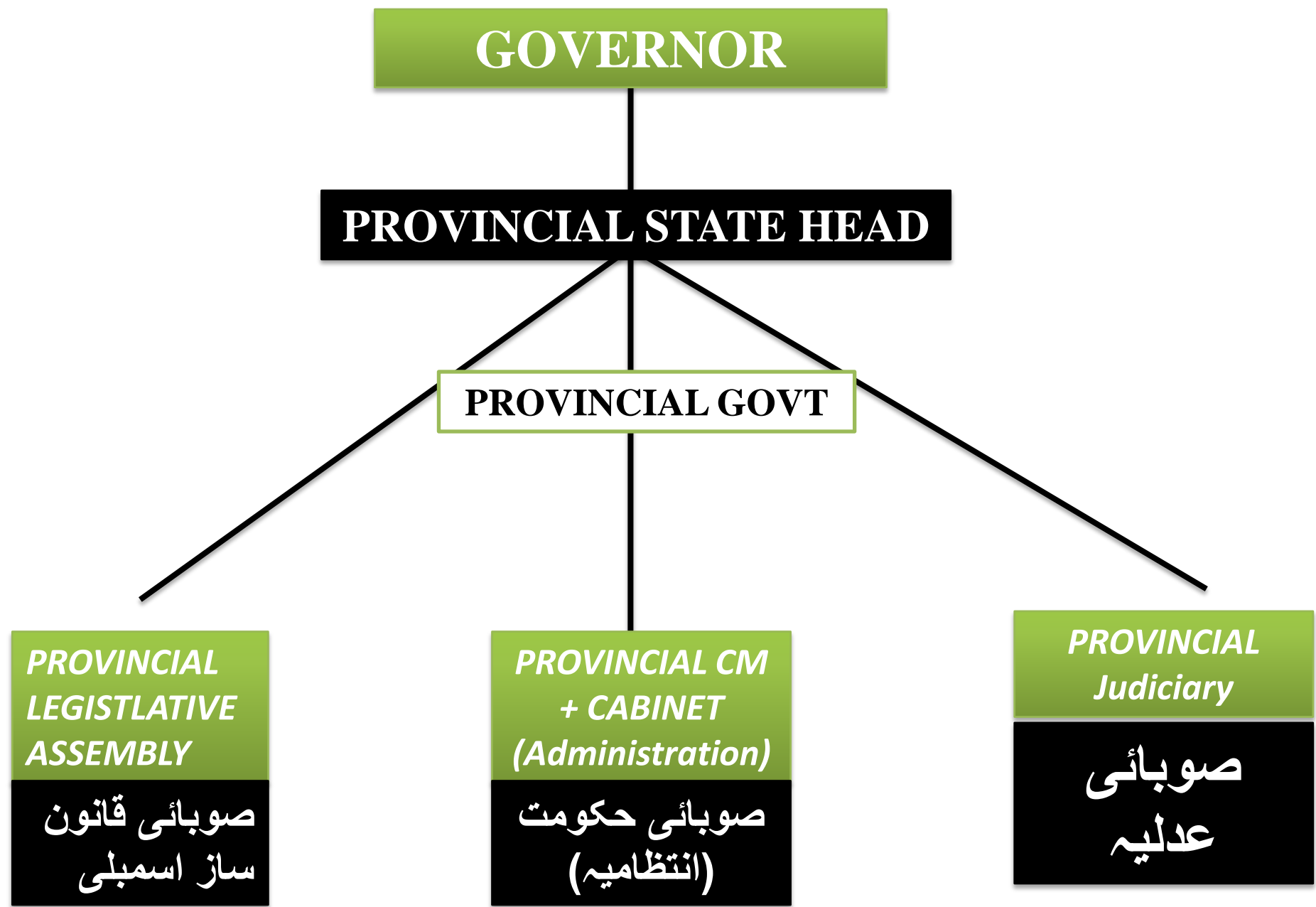
Article 7 of the Constitution of Pakistan Defines Definition of the State

*The **State**" means the Federal Government, Majlis-e-Shoora (Parliament), a Provincial Government, a Provincial Assembly, and such local or other authorities in Pakistan as are by law empowered to **impose any tax or cess.***

THE JUDICIAL PILLAR (BRANCH) OF THE GOVERNMENT

- **Legal arm of the government**
- Constitution provides for the “separation of judiciary from the executive” and the “independence of judiciary”
- Entrusts the superior courts with an obligation to “preserve, protect and defend” the Constitution
- Consists of
 - Supreme Court
 - High Courts
 - Federal Shariat Court
 - Subordinate Judiciary

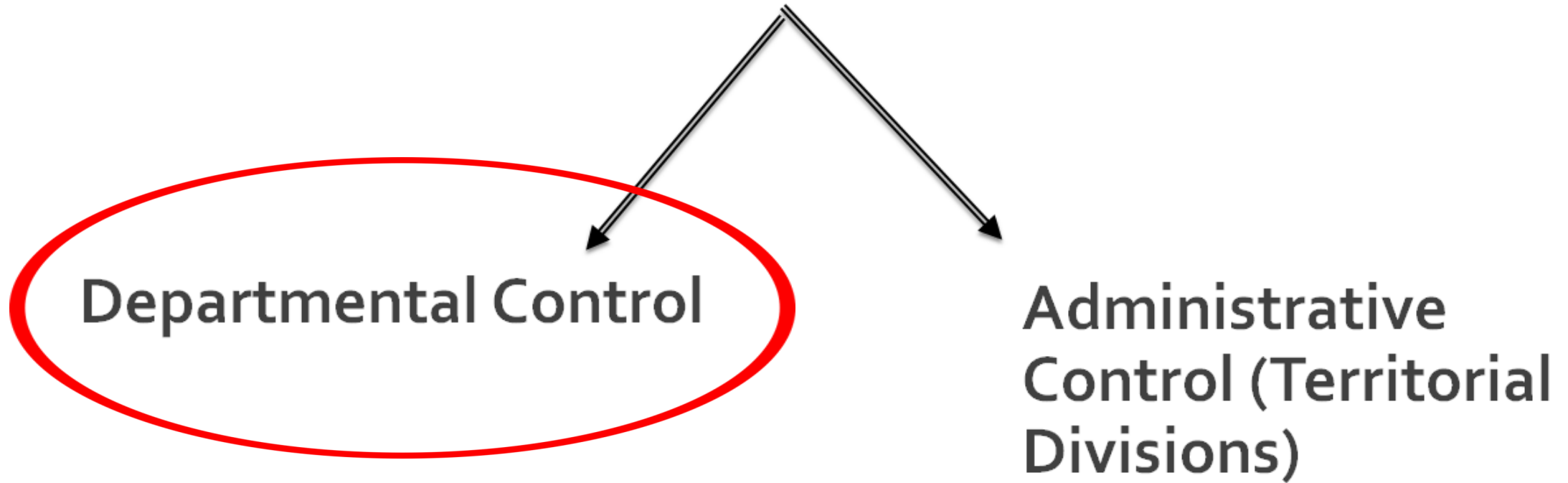
Provincial Government Structure

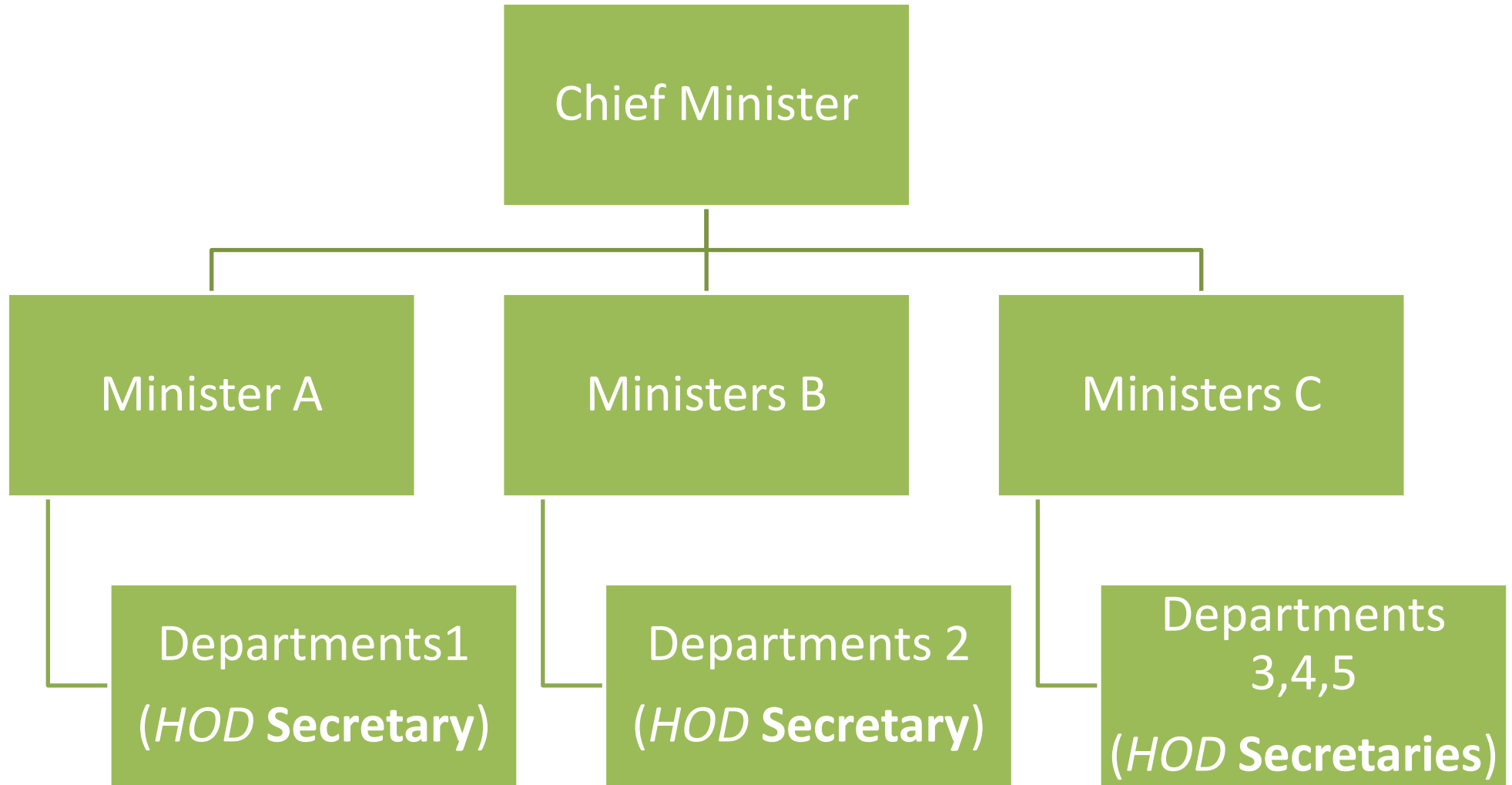


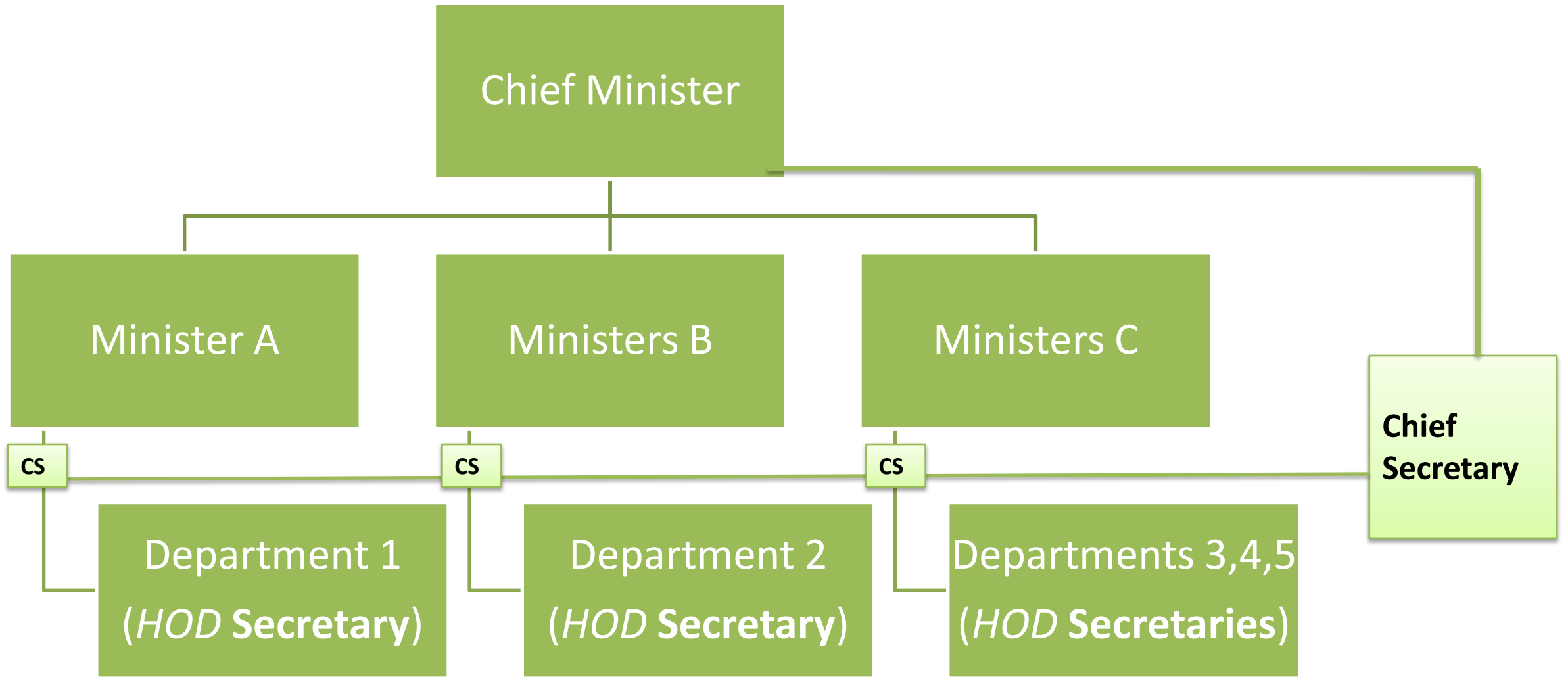
